AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Anderson Island Fire and Rescue from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll/personnel
- Payments/expenditures
- Open public meeting minutes
- Accounting/financial reporting
- Safeguarding of small and attractive assets such as computers

INFORMATION ABOUT THE DISTRICT

Pierce County Fire Protection District No. 27 provides 24-hour volunteer basic life support, fire suppression services and fire education services for Anderson Island. The District has three full-time employees and 22 volunteer firefighters.

The District is governed by a three-member Board of Commissioners elected to staggered, six-year terms. The District operates on an annual budget of less than \$1 million.
